Externally, there are 6 dedicated parking spaces available.

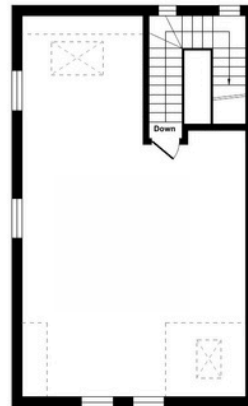

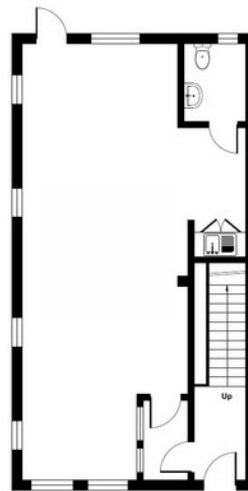
Green Lane, Clifton, York, YO30



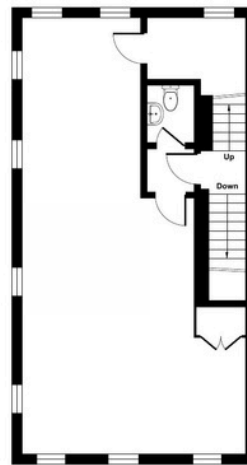
SECOND FLOOR

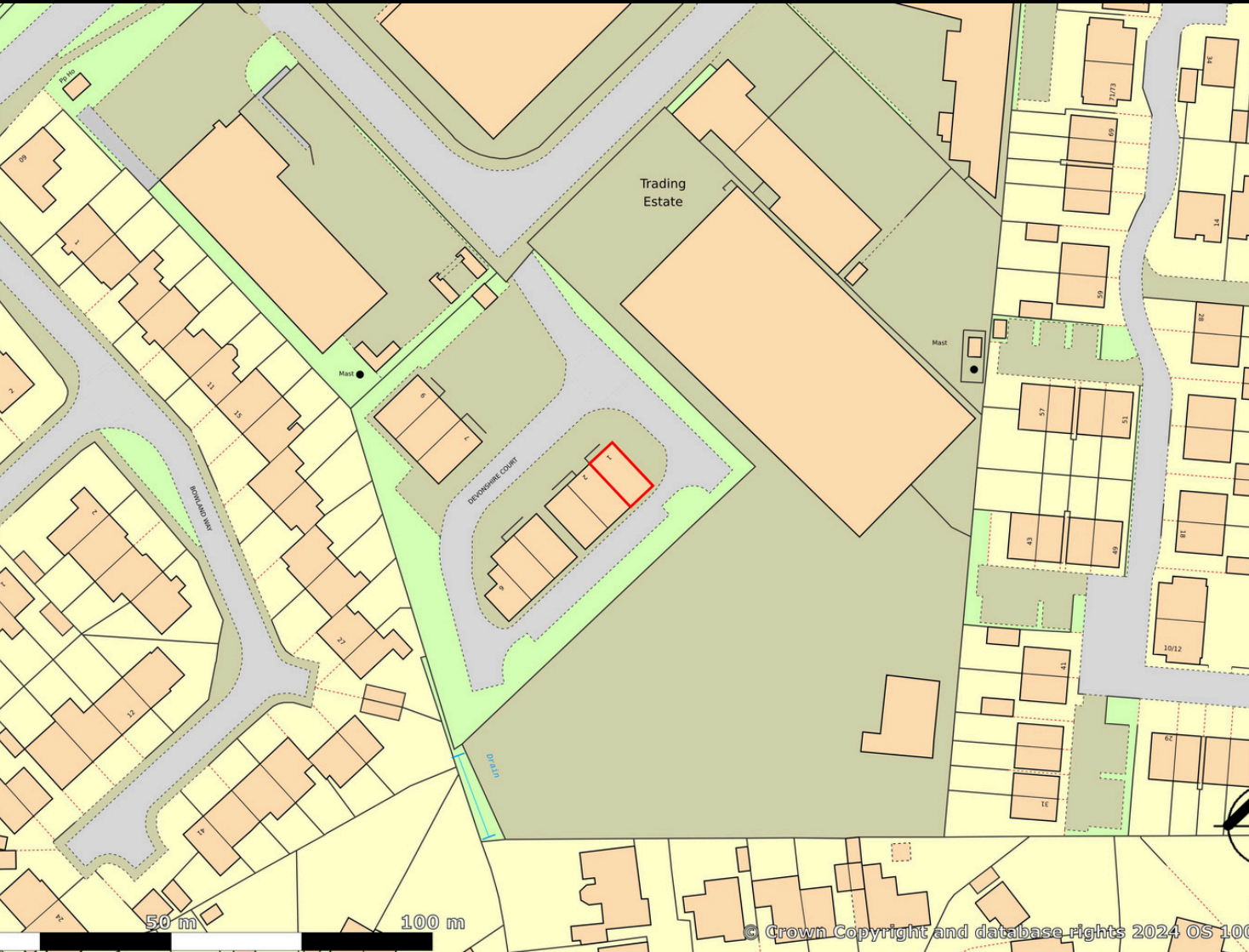
